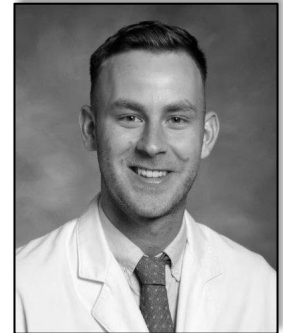

Board of Directors Responsibilities

Duties of the Board

- Provide ongoing direction for planning, operation and evaluation of ACMS services and ACMS Foundation activities.
- Establish policy, determine programs, approve annual budget, and represent ACMS to the medical community.
- Appoint and oversee the Executive Director.
- Be active in society meetings throughout the year, serving as informal hosts to make newcomers feel welcome and get connected, and representing the organization in the medical community.

Board Meetings

- Board meetings are held the second Monday of each month, 12 noon-1:15 p.m. at the IMA Building in downtown Boise. Lunch is provided.
- Board members should be able to attend more than 75% of meetings in person, plus other planning or committee meetings as the president directs, and come prepared to contribute to discussions.
- The July meeting is often cancelled, depending on the timing of the IMA Annual Meeting & House of Delegates.

Other Obligations of Board Members

Board members should plan to be active in society meetings throughout the year. ACMS Board members are expected to serve for up to 8 years beginning as a member-at-large (4 years) and working up through the officer positions: secretary/treasurer, president-elect, president and past president positions. Additionally, it is important that board members play a role in promoting a cohesive medical community and avoid conflicts of interest.

Specific board member qualifications are defined in the by-laws. Questions about board of director's responsibilities may be directed to the ACMS Director or current or past president. The ACMS maintains Director and Officer Insurance for their protection.

Board of Directors Nomination Form

The ACMS Board of Directors accepts self-nominations from ACTIVE PHYSICIAN members in good standing who are willing to fulfill the responsibilities of a board member. Any ACMS member interested in placing his/her name in nomination is asked to sign and return this form to the ACMS office by August 31, 2019. The Board of Directors' officers will select candidates to fill the open positions and present the nominees names, along with the 2019-20 slate of officers and directors, for approval at the Annual Meeting in October.
